NOTICE: If you have a secured debt and you want to keep the property which secures that debt, YOU MUST KEEP MAKING YOUR PAYMENTS. For

example, if you have a car loan or home mortgage and you want to keep your car and home you must keep making your payments to those particular creditors even though you are filing Chapter 7 bankruptcy.
